**PETITION TO INTERVENE OF  
BRIDGEWATER POWER COMPANY, L.P.**

Pursuant to Admin. Rule Puc 203.17 and RSA 541-A:32,I(b), Bridgewater Power Company, L.P. ("Bridgewater") requests intervention in this proceeding. This petition rests on the following grounds.


1. Bridgewater operates a wood-fired small power production facility and has a principle place of business located in Bridgewater, New Hampshire.
2. Bridgewater purchases backup power supply from Public Service Company of New Hampshire ("PSNH") under PSNH's Delivery Service Tariff, Backup Delivery Service Rate B and energy service under Rate LG.
3. Bridgewater also provides a diverse source of electric energy to the resource pool, electricity generated with biomass.
4. Bridgewater may be affected by the adequacy of PSNH's least cost integrated plan both as a consumer and as a provider of electricity. Consequently, Bridgewater has an interest in the adequacy of PSNH's planning process as defined by the requirements set forth in RSA 378:38 and 39 and Order 24,695 and consistency of that planning process with RSA Chapter 374-F and RSA 369-B:3a.
5. Bridgewater's intervention will not impair the prompt conduct of this proceeding.

WHEREFORE, Bridgewater respectfully requests that they be permitted to intervene in this proceeding as a full party.


