I am sure the chorine intake is not too good for your body when you are consuming it.

After months of suffering from a rash on my breast and legs and seeking medical attention, the final answer was not to take baths in chlorinated water. I can't drink it or bathe in it, and my wife also can't drink it. Now, what? As I have mentioned before, there was nothing wrong with the water before you came into the picture! This fiasco is shameful, and I have to buy bottled water!
