Notice of Intent to File Rate Schedules

Request for Waiver

Dear Ms. Knowlton:

On May 2, 2008, you filed on behalf of Pittsfield Aqueduct Company (Pittsfield) rate filings in accordance with N.H. Code of Admin. Rules Puc 1603.03. Within that filing, Pittsfield requested waiver of filing requirements contained in Puc 1604.01(a), specifically, 1604(a)(1), (18), and (25). Among other things, you contend that the information that Pittsfield would be required to produce to comply with these provisions is unnecessarily burdensome and duplicative.

On July 17, 2008, Staff filed its recommendation that the Commission grant approval stating that, after reviewing the waiver request, it believes a waiver is reasonable.

Pursuant to Puc 201.05(a), the Commission has determined that granting the requested waiver is in the public interest and will not disrupt the orderly and efficient resolution of matters before the Commission. Accordingly, the Commission will waive the filing requirements contained in Puc 1604.01(a)(1), (18), and (25). However, in the event the Commission determines that the pertinent information is otherwise relevant, it retains the authority to terminate its waiver.
