Dear Ms. Howland:

On August 19, 2009, Pennichuck Water Works, Inc. (PWW) submitted to Staff a proposal to recoup rate case expenses incurred in the above-captioned docket totaling \$119,515.67. PWW's submission was made in accordance with the terms of the Settlement Agreement which was recently approved by the Commission in Order No. 25,006 issued on August 13, 2009. The Settlement Agreement recommended that PWW be allowed to recoup its rate case expenses in the form of a one-time surcharge to its customers, shown as a separate item on all customers' bills. The approximate surcharge contemplated in the Settlement Agreement was \$4.00 per customer. In its submission to Staff, PWW proposed a one-time surcharge of \$4.58 per customer based on a customer count of 26,123 as of June 30, 2009. A copy of PWW's proposal and supporting schedules is attached to this correspondence.

PWW's submission included copies of invoices in support of the individual costs comprising the total amount being sought for recovery. Staff reviewed each cost submitted by the Company and is recommending that an amount of \$472.50 be eliminated from the total as it represents the cost of a legal notice relative to an NHPUC docket for one of PWW's affiliates. With the elimination of this amount, the total amount recommended by Staff for recovery is \$119,043.17. Based upon this amount, the one-time surcharge recommended by Staff is \$4.56 per customer.

The Company has indicated that it concurs with the above recommendations made by Staff. Please feel free to contact me with regard to any questions that you may have concerning this matter.
