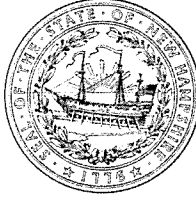

Certification Application for Class I Eligibility pursuant to RSA 362-F

Dear Mr. Silkman:

On September 2, 2008, Beaver Ridge Wind, LLC (BRW) submitted an application requesting certification for the Beaver Ridge Wind project (Beaver Ridge) as eligible to produce Class I renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law. Staff has reviewed the application and recommended approval, noting that the Beaver Ridge application was complete on September 2, 2008.

Pursuant to RSA 362-F:4, I, Class I eligibility requires that a facility began operation after January 1, 2006, and produces electricity from wind energy, among other technologies. The application indicates that the Beaver Ridge Wind facility is a wind turbine project consisting of three GE 1.5 MW wind turbines with a gross nameplate capacity of 4.5 MW located in the Town of Freedom, Maine. Beaver Ridge Wind has a target commercial operation date of November 1, 2008, but anticipates some prior generation during its commissioning period. The facility's NEPOOL generation information system facility code is unavailable at this time but will be provided to the Commission when obtained.


The Commission has reviewed Beaver Ridge Wind, LLC's application for the Beaver Ridge Wind facility and determined that it has provided all the necessary information to demonstrate that the Beaver Ridge Wind facility is eligible for certification as a Class I facility. Therefore, the Commission hereby certifies that Beaver Ridge Wind, LLC's wind facility is a Class I renewable energy source effective September 2, 2008, and is eligible to be issued New Hampshire Class I renewable energy certificates.

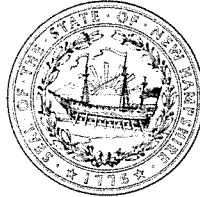

Dear Mr. Webb:

Please be advised that, pursuant to NH RSA 362-F, the New Hampshire Public Utilities Commission has certified Beaver Ridge Wind, LLC's Beaver Ridge Wind (Beaver Ridge) facility as a Class I renewable energy source effective September 2, 2008. Accordingly, Beaver Ridge is eligible to be issued New Hampshire Class I renewable energy certificates.

The Beaver Ridge facility is a wind turbine project consisting of three GE 1.5 MW wind turbines with a gross nameplate capacity of 4.5 MW located in the Town of Freedom, Maine. Beaver Ridge Wind has a target commercial operation date of November 1, 2008, but anticipates some prior generation during its commissioning period. The facility's ISO-NE asset identification number is unavailable at this time, but will be provided to the Commission when obtained. The New Hampshire RPS certification code is NH-I-08-014.
