Dear Ms. Stern:

On October 21, 2008, Nautilus Energy (Nautilus) submitted an application requesting certification of the Thule Corporation facility as eligible to produce Class II renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the application and recommended approval noting that the Lee application was complete on October 21, 2008.

Class II eligibility requires that a facility began operation after January 1, 2006 and that it produces electricity from solar technologies. The application indicates that the Thule Corporation has installed solar photovoltaic equipment with a gross nameplate capacity of 0.318 megawatts located at 42 Silvermine Road, Seymour, Connecticut and that the facility began commercial operation in October 2008. According to the application, the ISO-NE asset identification number is not applicable as the Thule facility is a behind-the-meter source. The application also indicated that the NEPOOL generation information system (GIS) facility code was not yet available and would be provided to the Commission when obtained.

The Commission has reviewed Nautilus' application and determined that it has provided all the necessary information to demonstrate that the Thule facility is eligible for certification as a Class II facility. Therefore, the Commission hereby certifies that the Thule facility is a Class II renewable energy source effective October 21, 2008 and is eligible to be issued New Hampshire Class II renewable energy certificates.


