

On May 14<sup>th</sup>, 2009, Merrimack County Telephone Company (MCTC) and Kearsarge Telephone Company (KTC) filed a proposal to add Customized 911, or C911, to MCTC's NHPUC tariff No. 9 and KTC's NHPUC tariff No. 8.
