The purpose of this letter is to inform the New Hampshire Public Utilities Commission that on April 1, 2010 Florida Power & Light Company filed with the Federal Energy Regulatory Commission the application requesting authorization pursuant to section 203 (a)(1) of the Federal Power Act for the transfer by FPL to New Hampshire Transmission, LLC of FPL's share in the Seabrook Transmission Substation. In the Joint Application filed with the Commission in the above-captioned docket, the parties stated that they intended to file the section 203 application with FERC and committed that they would notify the Commission of the outcome of the FERC proceeding. The FERC docket number for this filing is EC10-58-000; we will let the Commission know the outcome of this proceeding.
