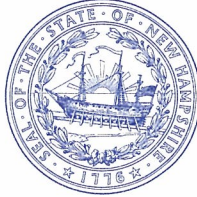

Extension of Time

To the Parties:

On September 11, 2012, Public Service Company of New Hampshire, Granite State Electric Company, and Unitil Energy Systems, Inc. (Electric Utilities) filed a joint motion for extension of time. In Order No. 25,402 (August 23, 2012), the Commission directed the Electric Utilities to "file ancillary savings data as well as a description of the reliability and accuracy of the data in the form of a report to be submitted with the 2013-2014 CORE program year filing." That filing is due September 17, 2012. The Electric Utilities seek an extension of time in order to hire a consultant to compile the report and expect it to be complete "early in 2013." The Electric Utilities also represent in the motion that the New Hampshire Electric Cooperative agrees with the motion.

The Commission has determined that the extension will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the Electric Utilities' motion has been granted and the report is due no later than March 29, 2013.
