This letter is being provided to express full support for the Berlin Laidlaw biomass project and request the PUC's approval of all necessary regulatory requirements. This project is the single greatest opportunity to ignite the depressed economy of the northern half of the state of New Hampshire.

Renewable energy is the single most significant opportunity to grow our economy and provide the much needed jobs of the future. Here in our state we have clean energy resources, such as wind, water and biomass to help supply the growing demand for energy, stimulate the economy and create hundreds of much needed jobs, while preserving the environment.

Please accept this letter in support of the proposed purchase power agreement between Public Service of New Hampshire (PSNH) and Laidlaw Berlin BioPower LLC (Laidlaw).

As the New Hampshire Public Utilities Commission is aware, the New Hampshire Legislature has passed several laws to mandate the purchase of renewable energy by New Hampshire utilities. The foundation of this public policy is New Hampshire's Renewable Portfolio Standard (RPS) law, which mandates that New Hampshire electric utilities purchase renewable energy certificates (RECs) from eligible renewable energy facilities. It is my understanding that the agreement between PSNH and Laidlaw includes the purchase of RECs, and largely satisfies PSNH's Class I requirements under the RPS law. Because of this, I believe approval of this purchase power agreement is consistent with the Legislature's intent under the RPS law.

In addition, one of the guiding purposes of the RPS law is that "the use of renewable energy technologies and fuels can also help to keep energy and investment dollars in the state to benefit our own economy". To that end, PSNH's purchase power agreement will provide the economic foundation for the development of a key in-state renewable energy generating facility and will ensure that the economic benefits are maximized by directing renewable energy funds to an in-state project.

A critical economic benefit of renewable energy development is job creation, and approval of this agreement and development of the Laidlaw project will create hundreds of jobs in northern New Hampshire. According to the economic data developed by Dr. Shapiro, approximately 470 jobs will be created in the construction phase of this project, and approximately 240 jobs will be created to support the operation of the facility and the harvesting of wood fuel. Given that Coos County's unemployment rate far exceeds the



unemployment rates in other counties and the state's unemployment rate, these jobs are critical to the economic stability and future growth of the region.

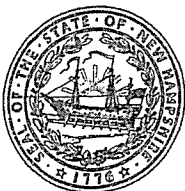

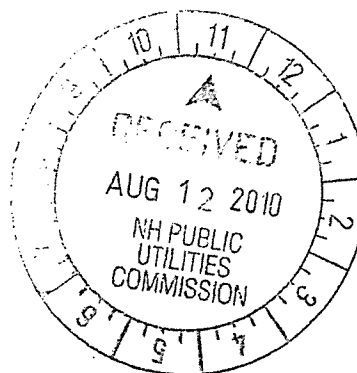


I am pleased to provide this letter in support of the purchase power agreement between Public Service of New Hampshire (PSNH) and Laidlaw Berlin BioPower LLC. I believe this agreement will provide the foundation for the successful development of a key biomass facility in the City of Berlin, and deserves support from the NH Public Utilities Commission.

As a member of the NH State Senate, I have been pleased to support many of the renewable energy laws that have been enacted by the state in recent years. Among these was the creation of a Renewable Portfolio Standard law (RSA 362-F), and the establishment of incentives for utilities to increase their use and investment in renewable power. Consistent with this law, the PSNH/Laidlaw agreement will provide benefits to New Hampshire by supporting in-state renewable energy development and to New Hampshire electric customers by ensuring cost effective access to renewable power.

This purchase power agreement will also provide the foundation for the successful development of this project by securing a market for its energy output and ensuring its long-term financial stability. Because of this, NH PUC approval of the agreement is critical to realizing the tremendous economic benefits associated with the project. Economic estimates by both PSNH and Laidlaw suggest that as many as 470 jobs will be created during the construction phase of this project and approximately 240 jobs will be created or supported through the plants operation and the harvesting of wood to fuel the facility. It can be expected that a majority of these jobs will be created in northern New Hampshire, a region of the state that has seen significant economic hardship and unemployment in recent years.

NH PUC approval of this purchase power agreement is a critical step in realizing the tremendous environmental and economic benefits associated with this project. The citizens of Berlin and northern New Hampshire have worked hard to support the development of the Laidlaw project, and I encourage the NH PUC to support their work by approving this purchase power agreement.

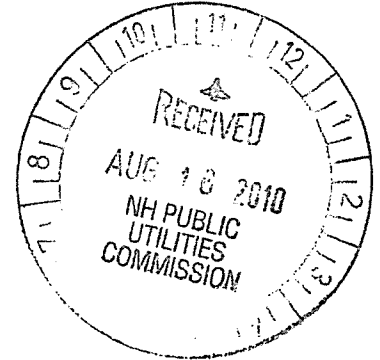



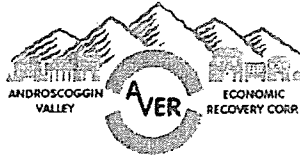

I thank you in advance for your time and consideration regarding the above proposal.

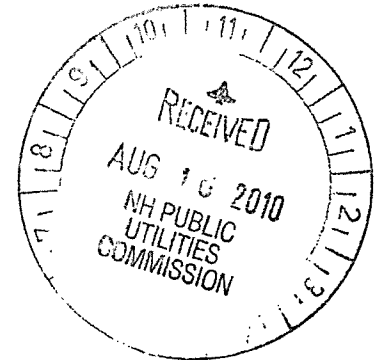

Dear Ms. Howland,

This letter is being provided to express full support for the Laidlaw Berlin BioPower, LLC biomass project in Berlin and request the PUC's approval of all necessary regulatory requirements. The Androscoggin Valley Economic Recovery Corporation (AVER) is extremely supportive of the effort to bring the Laidlaw project to completion for the substantial economic benefits that it would create for the region. AVER along with its partners have worked for years to help create economic development and jobs in the region. The retention and creation of jobs in our region and Coos County has been a priority for AVER. One of the primary messages we have heard from our community was the desire to create good paying jobs with benefits and jobs that would not be lost to China or other overseas foreign competition. Biomass energy facilities, including Laidlaw's and Clean Power's, satisfy these requirements. Biomass energy facilities in essence "manufacture" electrons which currently cannot be imported from overseas. This project would displace foreign imported oil and help reduce the region's high level of unemployment especially in the forest products industry. It is estimated that the Laidlaw project would create over 240 jobs without considering multiplier effects. Laidlaw would be purchasing over \$20,000,000 annually of wood product from local and regional wood products suppliers. The Androscoggin Valley and all of Coos County have enormous potential for the development of the renewable alternative energy industry. The Laidlaw biomass project contributes significantly to the orderly development of the alternative energy industry in the region. In order to achieve this economic development, approval by the PUC is required and AVER is advocating for and supporting such approval.

As the Chair of the Community EFSEC Advisory Committee, a community advisory committee formed to address the residents' concerns about the Laidlaw project, we reviewed all of the issues raised. 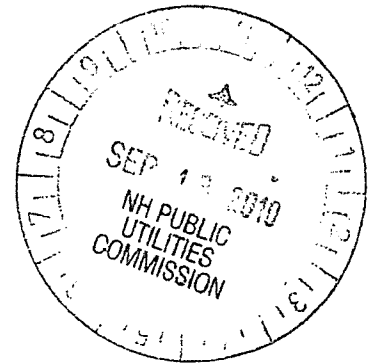

I am writing in support of the proposed purchase power agreement between Public Service of New Hampshire and Laidlaw Berlin BioPower LLC. 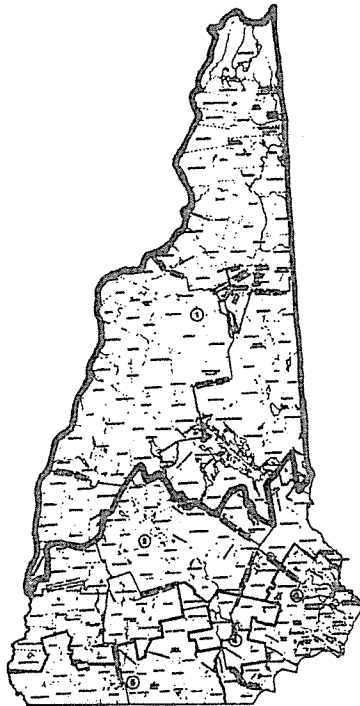

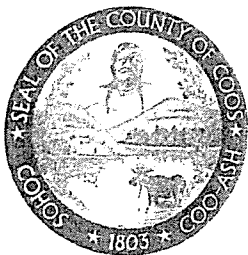

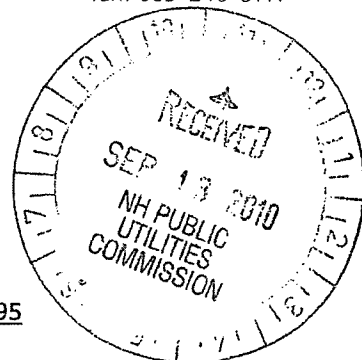

Dear Ms. Howland:

The Coös County Commissioners formally voted on September 8, 2010 to urge the Public Utilities Commission to review and approve the PSNH – Laidlaw Berlin Biopower purchase agreement as promptly as possible.

Laidlaw's project financing must close by the end of the year to take advantage of New Market Tax Credits (NMTC) totaling \$43.5 million. As part of the NMTC agreement, Laidlaw has made a commitment to establish a \$500,000 fund that will be directed by the NH CDFA for use in the Berlin area.

Coös County is still reeling from the loss of timber industry jobs due to mill closings in Berlin and Northumberland as well as the closing of Ethan Allen, Inc. which employed over 50% of its workforce from northern Coös County. The jobs that will be created by the Laidlaw Berlin Biopower project are estimated to peak at 300 jobs during the 2 year construction period, with a permanent increase of 40 direct and 200 indirect jobs when complete. Both the short and long term economic impacts of this project will once again infuse this County with much needed life blood from our renewable forests.

Additionally, Laidlaw has agreed to supply hot water to the Fraser Paper Mill in Gorham and it is our goal to keep this "last of the Mohicans" mill open, productive and profitable. Papermaking is an industry that has defined Coös County for over a century and your approval of the power agreement is an essential piece of the Coös County economic structure.

The Laidlaw assets will add to the tax base of Berlin which seriously declined when the Burgess Paper mill was dismantled. Berlin is Coös County's only city and a stronger Berlin means a stronger Coös County.

Once again, we urge you to act favorably on the Laidlaw BioPower, LLC petition for approval of its Power Purchase Agreement with Public Service of New Hampshire.

This letter is being provided to express full support for the Laidlaw Berlin BioPower, LLC biomass project in Berlin and request the Site Evaluation Committee's (SEC) and the Public Utilities Commission's (PUC) timely approval of all necessary regulatory requirements. The Androscoggin Valley Economic Recovery Corporation (AVER) is extremely supportive of the effort to bring the Laidlaw project to completion for the substantial economic benefits that it would create for the region. This support is contingent on the "City of Berlin Proposed Certificate Conditions" (stipulations) being made a part of the site certificate. We understand that those conditions have been agreed to by the City of Berlin and Laidlaw.

The timely approval of this project by the SEC and PUC, so that it can commence this year, is critical to the realization of substantial federal benefits and community benefits. These potential benefits could be lost in the event of unnecessary procedural delays. They include:

- \$44.5 million in federal New Market Tax Credit Authority
- \$2.25 million of the NMTC as a Community Loan Fund
- \$2.25 million of matching leveraged funds from the Community Loan Fund
- \$250,000 of the NMTC in grants for job, equipment, safety and responsible forestry practices training.
- \$20 million in ARRA Recovery Zone Facility Bond Financing Authority
- \$500,000 City of Berlin, NH Targeted Economic Development Funding

Additional Community benefits include:

- A "River Walk" along the Androscoggin River for community use
- An ATV/Snowmobile trail along Hutchins and Coos Streets
- Landscaping and new fencing
- Sponsorship of local events and social activities
- Plant tours to educate and promote alternative energy
- Low cost thermal energy to the Fraser plant and other collocating businesses.
- Priority hiring of local workers
- Local purchases of biomass
- A community parking lot
- A student intern program to develop alternative energy.

These benefits are too important to our economy and local jobs to be lost and the project jeopardized due to unnecessary procedural delays.



It is estimated that the Laidlaw project would create over 240 jobs without considering multiplier effects. Laidlaw would be purchasing over \$20,000,000 annually of wood product from local and regional wood products suppliers. The construction phase would create up to 470 jobs and infuse tens of millions of dollars into the local and regional economies.

The Androscoggin Valley and all of Coos County have enormous potential for the development of the renewable alternative energy industry. The Laidlaw biomass project contributes significantly to the orderly development of the alternative energy industry in the region. In order to achieve this economic development, approval by the SEC and PUC is required and AVER is advocating for and supporting such approval.

As the Chair of the Community EFSEC Advisory Committee, a community advisory committee formed to address the residents' concerns about the Laidlaw project, we reviewed all of the issues raised. All of the issues had manageable solutions and in addition Laidlaw would provide substantial community benefits. The City of Berlin and Laidlaw have agreed to a final list of proposed certificate conditions.

We believe the long-term success of this project will impact the regional economy favorably and will help to sustain and create jobs and move New Hampshire forward in the renewable energy arena. Thank you for your favorable consideration of this very positive and worthwhile project.

FRASER PAPERS TERMINATES AGREEMENT TO SELL NEW HAMPSHIRE PAPER MILL

Toronto, ON (September 28, 2010) – Fraser Papers Inc. (together with its subsidiaries, "Fraser Papers" or the "Company") announced today that it has terminated the agreement to sell its paper mill in Gorham, New Hampshire. The Company announced that the purchaser could not secure sufficient financing to complete the transaction. The Company has begun contacting other parties to determine their interest in acquiring the mill. Fraser Papers also announced that it will close the mill indefinitely while the Company continues its efforts to sell the mill. The Company plans to shut down the Gorham mill indefinitely on or about October 13, 2010, depending upon whether acceptable orders can be obtained. The Company noted that the shutdown is due to current market conditions and is in no way reflective of the outstanding dedication and commitment of the employees at the mill who have worked tirelessly to ensure Fraser Papers' paper products are of the highest quality. In conjunction with the anticipated shutdown of the of the Gorham mill, Fraser Papers has provided notice to the employees of the Gorham mill under the Worker Adjustment and Retraining Notification ("WARN") Act. Fraser Papers remains under creditor protection pursuant to the provisions of the Companies' Creditors Arrangement Act ("CCAA") in Canada and Chapter 15 of the United States Bankruptcy Code in the United States.


I am writing this letter to you in my official capacity as Mayor of the City of Berlin. First of all, I want to thank you for your service to the citizens of New Hampshire. Issues that you face on a daily basis are difficult and complicated, and interpreting law is never a simple task. I also commend you for conducting the September 29th hearing in a manner that allowed all parties to have their say.

When I presented myself to the voters of Berlin last fall, I made my positions on economic development very clear and concise. I fully supported the proposed Laidlaw Berlin Biopower project in the belief that it is in the very best interest of our citizens. The direct employment opportunities, the enormity of the economic benefits to our local economy in terms wood fuel purchases and procurement would have an immediate longterm favorable impact to all of Coos County. It was an election that saw Berlin's voters agree with my positions on the Laidlaw project by a 60-40% margin. The vast majority of the community can see the obvious benefits, as does most of the elected local and state officials.

The proposed power purchase agreement (PPA) between NH's largest utility, PSNH, and Laidlaw Berlin Biopower, is before you for consideration. It is also the last remaining item for regulatory review. You are tasked with determining if the terms of the agreement are in the best interests of New Hampshire's ratepayers, not competing power producers who will still do very well in NH's unregulated business environment. This review process needs to be diligent and thorough, but in light of the recent announcement that 240 residents and taxpayers jobs are in real jeopardy of being lost, I plead that an expedited decision process takes place.
