CLF and PSNH are continuing to work together to reach agreement on mutually acceptable language for a Nondisclosure agreement as requested by PSNH as a prerequisite to providing responsive information, most recently exchanging drafts and extensively discussing while together at the Technical Conference conducted on June 22, 2011. PSNH continues to express its intent to provide responsive information for said data requests upon execution by PSNH and CLF of a Nondisclosure Agreement. [As requested by PSNH, at the Technical Conference CLF returned all documents under a previous Confidentiality Agreement between said parties in DE10-121.] In the event that the CLF and PSNH are unable to reach an agreement on confidential treatment or the response filed under the confidentiality agreement is insufficient, CLF hereby reserves its right to file a motion to compel in this proceeding.

I write to inform the Commission of a discovery issue in the above-captioned proceeding which Conservation Law Foundation (CLF) and the Public Service Company of New Hampshire (PSNH) are working in good faith to resolve.

PSNH's response to data request CLF-02 was due on May 20, 2011. PSNH's initial response, however, was not provided until June 1, 2011. PSNH has indicated that it will provide certain responsive information for said data requests upon execution by PSNH and CLF of a Nondisclosure Agreement and return of all documents under a previous Confidentiality Agreement between said parties. The parties are working on mutually acceptable language for a Nondisclosure Agreement and are hopeful that it will not be necessary for the CLF to file a motion to compel. However, in the event that the CLF and PSNH are unable to reach an agreement on confidential treatment or the response filed under the confidentiality agreement is insufficient, CLF hereby reserves its right to file a motion to compel within fifteen business days after June 1, 2011 (i.e., June 22, 2011). Counsel for PSNH has assented to the foregoing extension of time for a motion to compel, if necessary.
