This is to confirm that the New Hampshire Public Utilities Commission (Commission) has received World Energy Solutions, Inc.'s (World Energy) notice of intent to renew its registration as a provider of electric aggregation service in New Hampshire pursuant to Puc 2003.05. Staff has reviewed the application provided and believes that it meets the requirements of Puc 2003.05. Based on Staff's recommendation and the Commission's review, the Commission approves World Energy's application to renew its registration as a provider of electric aggregation service in New Hampshire pursuant to Puc 2003.05.

Please note the following provision of Puc 2003.05 (f): "[E]ach approved aggregator shall re-notify the commission after the initial 2 year period, or after the 5 year renewal period as applicable, by filing with the commission an application for renewal at least 60 days prior to the expiration of the currently effective registration." World Energy's original notice anniversary date is November 16, 2006 and therefore it is required to re-file an up-to-date written notice on or before **September 17, 2015** if it continues to offer and provide electric aggregation service. In addition, Fawcett Energy Partners, Inc. is subject to the provisions of Puc 2004.03, telephone solicitation of customers, and Puc 2004.08, customer protections provided by aggregators.
