By letter dated November 17, 2015, National Grid USA (National Grid) filed a request for Commission authorization to release the full balance of non-earmarked escrow funds maintained in accordance with the terms of the Settlement Agreement reached in the above-captioned docket (Settlement Agreement). Under Section 11 of the Agreement Regarding Process for Release of Escrow Funds dated July 20, 2012 ("Escrow Release Agreement"), entered into in conjunction with the Settlement Agreement,

National Grid shall submit to Staff written confirmation, substantially in the form attached [to the Escrow Release Agreement] as <u>Schedule 9</u> ("365 Days Certification"), 365 days following Day N, and thereafter National Grid may notify the Escrow Agent that it is authorized to release the balance of the non-earmarked Escrow Funds to National Grid.

The Day N certification was submitted to the Commission on October 10, 2014, confirming the occurrence of Day N as of September 30, 2014. The 365 Days Certification was submitted together with National Grid's letter dated November 17, 2015. Commission Staff (Steve Frink, Amanda Noonan, and Randy Knepper) have reviewed the November 17, 2015 filing and have confirmed that there are no "earmarked funds" as a result of issuance of a staff review notice based on National Grid's failure to comply with applicable performance metrics under the Settlement Agreement and the Escrow Release Agreement.

Based on National Grid's filing and Staff's confirmation, attached are a draft letter with the confidential Disbursement Request form for your signature, authorizing the release by the escrow agent to National Grid of the sum of \$7,500,000, representing the full principal balance of the remaining Escrow Funds.
