Dear Ms. Routhier:

This letter serves as a follow-up to Staff's January 18, 2012 recommendation in the above docket as well as subsequent communications from People's Power & Gas, LLC (PPG) in response to that filing. One of the issues addressed in the Staff recommendation involved PPG's website including New Hampshire as a jurisdiction in which PPG was accepting enrollments. There was no indication to prospective customers that PPG's supplier registration was pending and not yet approved. We have subsequently visited the website and noticed that New Hampshire was removed from the enrollment section. Thank you for your attention to that issue.

In order to complete the processing of PPG's application for registration as a competitive electric power supplier (CEPS) pursuant to RSA 374-F:7 and N.H. Code Admin. Rules Puc 2000, the following remaining deficiencies need to be addressed,

EDI Testing

In a letter dated January 23, 2012, it was stated that PPG had completed its EDI testing. Puc 2003.01(d) (1) a. requires an applicant for CEPS registration to provide a statement from each utility with which the CPES intends to do business indicating that the applicant has complied with the training and testing requirements for electronic data interchange (EDI). Although the January 23, 2012 letter states that PPG "has EDI tested in all Utilities successfully," PPG has only provided proof that it has completed EDI testing in the franchise territory of the New Hampshire Electric Cooperative (NHEC). PPG must supply statements from the other New Hampshire electric utilities verifying that all required EDI testing is complete. As of February 8, 2012, a check with Public Service

Company of New Hampshire revealed that while PPG has been in the process of EDI testing, it has not yet been fully completed. Therefore, PPG might want to confirm the status of its EDI testing with the New Hampshire electric utilities.

Terms and Conditions

PPG's application (as well as its website) includes "terms and conditions" that do not comport with the requirements of Puc 2004.02(b). PPG must file a copy of the terms and conditions that it will provide to electric customers in New Hampshire for Staff's review so that Staff can determine whether PPG has complied with the requirements of the rule. The rule is available on the Commission's website, www.puc.nh.gov.

Please provide paper and electronic copies of the requested documents within 30 days of the date of this letter. Please refer to Docket No. 11-066 in your correspondence with the Commission.
