Dear Mr. Howland:

I am responding to a letter to Mr. Fromuth in the above-captioned proceeding which notes two discrepancies in the Application for Registration filed with the Commission on April 4, 2011.

Freedom Logistics, LLC is a NH limited liability company created on August 14, 2006. Freedom Energy Logistics is a trade name for Freedom Logistics, LLC also created on August 14, 2006. Accordingly, we are re-submitting with this letter a revised natural gas aggregator registration application for Freedom Logistics, LLC d/b/a Freedom Energy Logistics.

Secondly, you also note that Halifax American Energy Company (HAEC) is not an approved CNGS in New Hampshire. However, HAEC is the exclusive New England marketing agent for natural gas (and electricity) for South Jersey Energy Company (SJE). SJE is an approved CNGS in New Hampshire. This is probably why the Application in this proceeding lists HAEC as a CNGS through which Freedom Logistics intends to provide service. Nonetheless, your point is well taken that HAEC is not an approved CNGS in New Hampshire and we have removed it from the re-submitted Application being re-submitted herewith.

Your letter also requests a "statement disclosing whether or not Freedom Energy Logistics, Freedom Logistics LLC, and any other entity affiliated with either company, have been in compliance with the requirement under N.H. Admin. Rule Puc 3003.04(a), regarding

customer solicitations, enrollments and contracting prior to being registered. "Rule Puc 3003.04(a) pertains to "natural gas aggregators." According to Rule Puc 3002.01, "Aggregate" means to combine the natural gas loads of 2 or more customers or a single customer with multiple meters or multiple locations. No affiliate of Freedom Logistics, LLC has acted in this capacity at any time.

HAEC is an affiliate of Freedom Logistics, LLC d/b/a Freedom Energy Logistics. As the exclusive New England marketing agent for natural gas (and electricity) for South Jersey Energy Company (SJE), HAEC has recently discussed natural gas supply with a very limited number of end-users. These discussions have made it very clear that HAEC is acting in the shoes of SJE, and not acting as a broker or aggregator.
