Dear Mr. Fromuth:

On April 4, 2011, Freedom Logistics, LLC, d/b/a Freedom Energy Logistics (Freedom) filed with the Commission an application for registration as a natural gas aggregator, together with the initial application fee of \$250.00. By letter dated April 21, 2011, after prior communication with Commission staff, Freedom filed a replacement registration application, with the paid initial application fee applied towards the replacement application.

The Commission has reviewed the application for registration as a natural gas aggregator, and related communications (including your explanatory letter dated May 23, 2011), and has determined that it meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.04. Therefore, the Commission will approve Freedom as a natural gas aggregator in the State of New Hampshire, with the registration to be effective June 1, 2011. This initial registration will expire at the end of business on May 31, 2013.

Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.05 (a), each aggregator applicant shall re-register with the Commission by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of Freedom, on or before April 1, 2013. All registered Natural Gas Aggregators in the State of New Hampshire are subject to specific requirements spelled out in N.H. Code Admin.
