Request for Modification of Competitive Electric Power Supplier Registration

NOW COMES PNE Energy Supply LLC (d/b/a Power New England) (hereinafter “PNE”) and respectfully motions the Commission to modify its Competitive Electric Power Supplier Registration, and in support hereof says as follows:

1. Pursuant to Rule Puc 2003.01, PNE’s Initial Application for Registration to become a Competitive Electric Power Supplier was filed with the Commission on April 11, 2011. The form of application is set forth in Rule Puc 2006.01.
2. On May 31, 2011, PNE submitted a Motion to Extend Period for Completion of Application citing “the unprecedented initiative by PNE to assemble an organization to serve residential customers in New Hampshire (some 12 years after “deregulation went into effect).”
3. The extension was granted by the Commission by Secretarial Letter dated June 19, 2011.
4. With respect to PUC 2006.01(a)(1), PNE indicated on its Application that “Applicant intends to serve only residential customers.”
5. In a Secretarial Letter dated September 22, 2011, the Commission approved PNE’s application to be registered as a competitive electric power supplier in the franchise area of PSNH. The approval did not contain an explicit limitation on the types of customers that PNE was authorized to serve.
6. PNE now wishes to modify its Competitive Electric Power Supplier Registration so that it explicitly authorizes PNE to serve commercial and industrial customers.


7. By virtue of the Commission's prior approval of PNE's application to be registered as a competitive electric power supplier on September 22, 2011, PNE intrinsically meets all of the requirements to serve commercial and industrial customers. If anything, the Commission's standards for approval to serve commercial and industrial customers are lower than those applicable to service to residential customers.

WHEREFORE, PNE respectfully requests the Commission to modify its Competitive Electric Power Supplier Registration so that it explicitly authorizes PNE to serve commercial and industrial customers.


