DE 11-099 Conservation Services Group's Application for Class II Eligibility of the Princeton Commons, 1 Technology Drive photovoltaic facility Pursuant to RSA 362-F on behalf of Princeton Crossings, L.P.

Dear Ms. Hamilton:

On April 20, 2011, Conservation Services Group (CSG) submitted an application on behalf of Princeton Crossings, L.P requesting certification of the Princeton Commons, 1 Technology Drive, Chelmsford, Massachusetts, (Princeton Commons) photovoltaic facility as eligible to produce Class II renewable energy certificates (RECs), pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard (RPS) law. Staff has reviewed all submitted information and recommends approval, noting the application was completed August 2, 2011.

Class II eligibility requires a facility to produce electricity from solar technologies and to have initiated operation after January 1, 2006. The application indicates that the Princeton Commons installation began operation on December 8, 2010, and is a customer-sited photovoltaic facility. The array is located on Building Number 1; the name plate capacity of the system is 30 kilowatts (kW), with a DC-STC-rating of 22.08 kW. The facility's New England Power Pool (NEPOOL) Generation Information System facility code is NON 32919.

Since the facility is a customer-sited source, its output is not recorded in the NEPOOL Market Settlement System and, as a result, its output must be monitored and verified by an independent monitor. The application states that Power Dash will monitor

the facility's output as required by the New Hampshire Code of Administrative Rules Puc 2505.09.

Princeton Properties Aggregation (Docket # 10-156) previously applied for and received GIS facility code NON 32919. This facility code, effective January 10, 2010, allows Princeton Crossing's L.P. independent monitor, PowerDash LLC, to report the total monthly output of the facilities including 1 Technology Drive, in lieu of reporting output individually for each facility. The New Hampshire single certification code for the Princeton Commons array is NH-II-11-017. The Princeton Properties Aggregation Class II REC code is NH-II-10-091.

Staff has determined that CSG has provided all the necessary information to demonstrate that the facility is eligible for certification to produce New Hampshire Class II RECs. Based on Staff's recommendation, the Commission hereby certifies that the Princeton Commons facility is a Class II renewable energy source effective August 2. To ensure CSG does not receive Class II RECs for output from facilities not approved for Class II eligibility, CSG must report to the Commission the total output associated with the facilities after August 2, 2011. Specifically, CSG must provide each facility's kilowatt-hours (kWh) produced during the relevant quarter, total kWh produced prior to the Commission approval date to produce Class II RECs, and total kWh produced after the Commission approval for Class II RECs. CSG must submit this quarterly data to the Commission before the NEPOOL GIS deadline for reporting customer-sited facility output. For example, for third quarter 2010 data, CSG must submit this data prior to January 10, 2011.

The New Hampshire Public Utilities Commission has certified the Conservation Services Group's Princeton Crossing L.P., Princeton Commons, 1 Technology Drive, Chelmsford, MA (1 Technology Drive) photovoltaic facility as eligible for Class II Renewable Energy Certificates (RECs) effective August 2, 2011 as required by NH RSA 362-F. Accordingly, the 1 Technology Drive project is eligible to be issued New Hampshire Class II RECs.

To ensure that CSG is only credited for Class II RECs from the output of facilities approved for Class II eligibility, PowerDash, LLC must verify and report to both the Commission and the NEPOOL GIS the total output associated with the facility after the Commission issued effective date of August 2, 2011.

The New Hampshire certification code for the Princeton Commons photovoltaic facility is NH-II-11-017; the New Hampshire certification code for the Princeton Properties Solar Aggregation is NH-II-10-091.
