Hi Sue, you were correct in opening an account. An account is needed to register a GIS asset, and get a facility code. Your account is already setup, so next is to register the asset in your account. Below are the steps to register your asset after logging in to your account. Let me know if you have further questions.

1. Once logged in to your account, click the "Register Non-NEPOOL Generator" link located towards the upper half of your account screen.
2. Fill out the 2 page generator form, only filling in the required fields
3. Skip the entire second page, and click the submit button at the bottom of the second page. The second page denotes RPS eligibilities, and I will update that field once the state regulator approves your generator as RPS eligible.
4. When you return to your home page, you will see your newly registered generator, with a corresponding Unit ID number. It will begin with "NON" followed by a series of numbers. This is the number the state regulator is looking for.
