On October 17, 2011, the Commission held a prehearing conference in the above captioned docket. The Commission's appointed its General Counsel, F. Anne Ross, to serve as hearings examiner. The Office of Consumer Advocate (OCA) filed a letter on October 12, 2011 stating that it would be participating in this docket on behalf of residential ratepayers pursuant to RSA 363:28. Conservation Law Foundation (CLF) filed a motion to intervene; Public Service Company of New Hampshire (PSNH) filed a timely objection to the motion. CLF requested an opportunity to respond in writing to PSNH's objection.

Following the prehearing conference, the Parties and Staff met in technical session and agreed to the following procedural schedule:
