In Order No. 25,646, the Commission directed counsel for PSNH and TransCanada to reconsider their respective positions concerning discovery issues in light of that order and meet face-to-face to review the outstanding data requests. PSNH and TransCanada had such good-faith discussions, resulting in resolution of the vast majority of pending issues. Following those discussion, one significant issue remains in dispute.
