In accordance with the procedural schedule issued by the Commission on May 16, 2014, Public Service Company of New Hampshire ("PSNH") hereby submits its rebuttal testimony.

PSNH's ability to fully and adequately respond to the testimony of other parties has been materially and adversely impacted by the refusal of TransCanada to provide responses to discovery questions relating to the forecast price of gas and to the effect of gas fracking. PSNH's witnesses testify to this impact.
