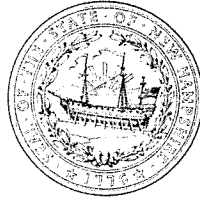

On January 12, 2012, FairPoint Communications - NNE (FairPoint) filed a special contract to provide a customer with Direct Inward Dialing service. Staff has reviewed the documentation filed in support of the special contract and recommended that it be allowed to go into effect. According to Staff, the contract rate meets the price floor requirements of RSA 378:18-b, II.

For administrative efficiency, the Commission will not issue an order suspending, rejecting, or approving the proposed contract. Accordingly, the proposed contract is effective February 11, 2012, pursuant to RSA 378:18-b, II. (a).
