Dear Mr. Howe:

On February 21, 2012, City Fuel Company Inc. (City Fuel) filed with the Commission an application for registration as a natural gas aggregator, together with the application fee of \$250.00.

Following its review of the filing, Commission Staff has determined that the application for registration as a natural gas aggregator meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.04. On March 23, 2012, Staff filed its recommendation to approve the application. The Commission will approve the registration with an effective date of April 1, 2012. The registration will expire at the end of business on March 31, 2014.

Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.05 (a), each aggregator shall re-register with the Commission by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of City Fuel, on or before January 31, 2014. Registration instructions and a checklist of requirements to properly file a renewal registration application are located on the Commission website at <http://www.puc.nh.gov/Gas-Steam/CNGS-Aggregator%20registration%20application%20instructions%20and%20checklist.pdf>.
