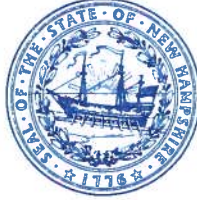

Request to Provide Replacement Corporate Guarantee

Dear Mr. Dearman:

On August 23, 2016, you filed on behalf of Electricity N.H., LLC d/b/a E.N.H. Power (ENH Power), a corporate guarantee dated August 1, 2016 in the amount of \$350,000 (new guarantee) to replace the corporate guarantee dated November 11, 2013 and filed with the Commission on December 2, 2013 (old guarantee). The new guarantee is executed by Spark Energy, Inc. (Spark Energy), and was filed together with notification that Spark Energy, Inc. acquired ENH Power on August 1, 2016. The new guarantee was proposed to replace the old guarantee executed by Noble Group Limited.

The new guarantee is in the amount of \$350,000, has a term that is continuing, names the Commission as the guaranteed party, and was executed by Spark Energy. Staff reviewed the new guarantee and believes its material terms and conditions to be acceptable, as confirmed in Staff's memorandum dated August 24, 2016.

Please be advised that the Commission has approved your request to replace the old guarantee with the new guarantee. Accordingly, the Commission accepts the new guarantee as replacement for the old guarantee to serve as financial security for ENH Power.
