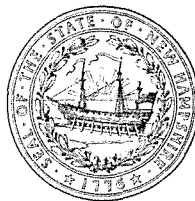

Withdrawal of Registration as an Electric Aggregator

Dear Mr. Dziemian:

On July 11, 2014, you filed a request with the Commission to withdraw the registration of White Columns Office Solutions of New England LLC (White Column) as an electric load aggregator in New Hampshire, effective as of June 30, 2014. In an e-mail to Staff, you confirmed that White Column has not served any retail electric customers in New Hampshire during the past 90 days.

The Commission's rules governing electric load aggregators do not provide for the withdrawal, rescission or abandonment of an aggregator's registration. The Commission has reviewed your letter and has deemed it a request for waivers of N.H. Code Admin. Rules Puc 2003.04 (g) (approved aggregator registration valid for two years), and Puc 2003.04 (i) (registered aggregator to continue compliance with requirements of Puc 2000). The Commission has determined that the requested waivers, without any further conditions, are in the public interest and will not disrupt the orderly and efficient resolution of matters before the Commission, and that the purpose of the rules will be satisfied by the termination of White Column's electric load aggregator registration, effective as of the date specified in the request letter.

Accordingly, White Column's electric load aggregator registration is deemed withdrawn and terminated, effective as of June 30, 2014.
