Ms. Howland;

We are seeking a ruling from the Commission regarding the standing of Neighborhood Energy of New England LLC as an aggregator for electric and natural gas supply. Specifically, White Columns Office Solutions of New England LLC (WCOS) merged with Neighborhood Energy of New England LLC (NENE) effective November 1st, 2014 (see enclosed document from the State of New Hampshire Department of State Corporate Division).

The following is our understanding:

1. NENE's term as an electric aggregator ends on October 2nd, 2015 as noted in DM 13-259 in a letter dated October 3rd, 2013. WCOS's term as an electric aggregator ends February 5th, 2017 as noted in DM 12-087 in a letter dated May 24, 2012. Therefore, as a result of the merger, NENE's term is now extended to February 5th, 2017.
2. WCOS submitted a renewal of its registration as a natural gas aggregator on February 4, 2013 and was granted a term that expires on March 31, 2018 in DM 13-043. NENE has not filed an application as a natural gas aggregator however our records show that a letter was created on June 30th 2014 to the Commission requesting a transfer from WCOS to NENE. We cannot confirm if the letter was submitted or if we received a response from the Commission. Therefore, as a result of the merger, NENE is a natural gas aggregator with a term that expires on March 31, 2018.

It is with respect and appreciation that the Commission confirms that our understanding is accurate or clarifies the status of NENE on when the term expires as an electric aggregator and if it can assume the WCOS license as a natural gas aggregator.

**FIFTH:** The merger is to become effective on November 1st, 2014



Dear Mr. Dziemian:

On February 4, 2013, White Columns Office Solutions of New England LLC (White Columns) filed with the Commission an application for renewal of its registration as a natural gas aggregator, together with the renewal application fee of \$125.00.

Following review of the filing, Commission Staff determined that the renewal application for registration as a natural gas aggregator meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.05. On February 7, 2013, Staff filed a recommendation to approve White Columns' application. The Commission will approve the registration with an effective date of April 1, 2013, which coincides with the expiration of the existing registration for the Company authorized in Docket No. DM 11-041. The renewal registration will expire at the end of business on March 31, 2018.

Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.05 (a), each aggregator shall re-register with the Commission by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of White Columns, on or before January 31, 2018. Please be sure to file a timely renewal application. Registration instructions and a checklist of requirements to properly file a renewal registration application are located on the Commission website at <http://www.puc.nh.gov/Gas-Steam/CNGS-Aggregator%20registration%20application%20instructions%20and%20checklist.pdf>.

All registered Natural Gas Aggregators in the State of New Hampshire are subject to specific requirements enumerated in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules can be found on our website at (<http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf>).

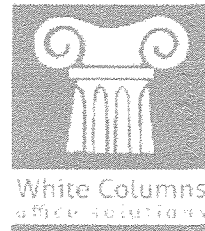

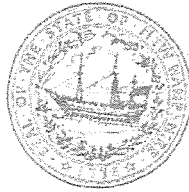

Re: DM 12-087, Notification of White Columns Office Solutions of New England's LLC's Intent to Provide Electric Aggregation Service

Dear Mr. Dziemian:

This is to confirm that the New Hampshire Public Utilities Commission (Commission) has received White Columns Office Solutions of New England's LLC (White Column)'s notice of intent to *renew its registration as a provider of electric aggregation service in the State of New Hampshire*, pursuant to New Hampshire Administrative Rules Puc 2003.05. Staff has reviewed the application provided and believes that it meets the requirements of Puc 2003.05. Based on Staff's recommendation and the Commission's review, the Commission approves White Column's application to renew its registration as a provider of electric aggregation service in New Hampshire.

Please note the following provision of Puc 2003.05 (f): "[E]ach approved aggregator shall re-notify the commission after the initial 2 year period, or after the 5 year renewal period as applicable, by filing with the commission an application for renewal at least 60 days prior to the expiration of the currently effective registration." White Column, Inc.'s original notice anniversary date is May 5, 2010 and therefore it is required to refile an up-to-date written notice on or before **February 5, 2017** if it continues to offer and provide electric aggregation service. In addition, White Column, Inc. is subject to the provisions of Puc 2004.03, *telephone solicitation of customers*, and Puc 2004.07, *customer protections* provided by aggregators. Finally, aggregators must comply with the requirements set out in RSA 362-F relative to the renewable portfolio standard (RPS) and RSA 362-F relative to disclosure of electric service energy sources and environmental characteristics. Please refer to Puc 2500 for further details regarding RPS reporting requirements. Commission Order No. 25,264 provides guidance as to the appropriate format for environmental disclosure.

On September 18, 2013, Neighborhood Energy of New England, LLC (Neighborhood Energy) submitted an application with the Commission to register as a provider of electric aggregation service. On September 25, 2013, Neighborhood Energy filed additional information for its application. Staff reviewed the application and determined that it is complete.

The Commission approves your application to register as a provider of electric aggregation service, effective October 3, 2013. The registration is for a term of 2 years and expires at the end of business on October 2, 2015. Pursuant to N.H. Code Admin. Rule Puc 2003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before August 3, 2015.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf>.
