Please find attached the final executable copy of the Large Generator Interconnection Agreement ("LGIA") for the Berlin Station, LLC project. This LGIA has been designated under the ISO Tariff as Original Service Agreement No. LGIA-ISONE/NU-11-02, with an "Issued Date" of June 24, 2011 (*i.e.*, today's date), and an "Effective Date" of July 18, 2011 (*i.e.*, 15 BD from issuance of final LGIA). Note that the LGIA contains Critical Energy Infrastructure Information, which must be protected in accordance with ISO Information Policy procedures.

Please have the corresponding officer in your company execute <u>three original copies</u> of the LGIA by no later than July 18, 2011. Send all three original copies to Linda Morrison at the address provided in my signature block, below. Upon receipt of all original signature pages, we will prepare three fully executed original copies, and mail a copy to each Party.

Also attached is a redlined version of the LGIA showing all of the changes made to the LGIA as a result of the ISO's legal review. The changes are ministerial in nature or otherwise remove language that referred to the pending Interconnection Request as this is the LGIA that will govern the entire project. We also revised Appendix C-3 – TIA to reflect the TIA that NU provided on June 14. NU's email also is attached.

Because the LGIA fully conforms to the current *pro forma* LGIA and all Parties will be executing it, the ISO and NU will not be filing the LGIA with FERC. Rather, in accordance with Order No. 2003, the ISO, in coordination with NU, will report the LGIA in its next Electronic Quarterly Report. Concurrent with the Effective Date of the LGIA, the ISO will reflect the termination of the existing three-party interconnection agreement that currently governs the interconnection of the Berlin Station, LLC project through the Electronic Quarterly Report.
