Request to Provide New Corporate Guaranty as Financial Security

Dear Ms. Williams:

On May 8, 2017, you filed on behalf of NextEra Energy Services New Hampshire, LLC (NextEra Energy), a corporate guaranty dated May 4, 2017 in the amount of \$350,000 (new guaranty) to provide financial security coverage under its current registration approved in Docket DM 12-145, for the period beginning on May 9, 2017 and ending on the termination date of that registration, June 9, 2017, and to meet the financial security requirements of NextEra Energy's pending application for renewal registration as a competitive electric power supplier (CEPS) in Docket DM 17-060. The new guaranty was executed by NextEra Energy Capital Holdings, Inc., of which NextEra Energy is an indirect wholly owned subsidiary, on May 4, 2017.

The new guaranty is in the amount of \$350,000, has a term that expires on July 9, 2022, and names the Commission as the guaranteed party. Staff reviewed the new guaranty and believes its material terms and conditions to be acceptable, as confirmed in Staff's memorandum dated May 8, 2017.

Please be advised that the Commission has approved your request to provide the new guaranty as financial security for NextEra Energy's current registration, approved in Docket DM 12-145, for the period beginning on May 9, 2017 and ending on June 9, 2017, and to meet the financial security requirements of NextEra Energy's pending CEPS registration renewal application in Docket DM 17-060.

Accordingly, the Commission accepts the new guaranty to serve as financial security for NextEra Energy's current registration, from May 9, 2017 to June 9, 2017, and NextEra Energy's pending CEPS registration renewal application.
