Dear Mr. Roesel:

On May 31, 2012, you filed on behalf of IDT America, Corp. (IDT) proposed rate changes to revise intrastate access rates to comply with the requirements of the Federal Communications Commission (FCC) in its order, *Connect America Fund et al.*, WC Docket No. 10-90 *et al.*, Report and Order and Further Notice of Proposed Rulemaking, 26 FCC Rcd 17663 (2011). The proposed revisions address the requirement that carriers reduce their intrastate access revenues. On July 1, 2012, IDT submitted rate sheets with an effective date of July 3, 2012. On August 13, 2012, IDT submitted supplementary information in support of its filing which indicated that the adjusted rates would capture more revenue than the revenue cap.

Following Staff's recommendation, on August 30, 2012 IDT submitted replacement rate sheets, and on September 10, 2012 a revised worksheet was received by the Commission. Staff reviewed these revisions and concluded that they are consistent with the FCC's requirements. The Commission has accepted Staff's recommendation that the rates conform to the requirements of the FCC's order. Further, the Commission has accepted Staff's recommendation that although the price sheet was submitted after the July 1, 2012 deadline established by the FCC, the rates in the price sheet should go into effect on July 3, 2012 as proposed, consistent with the requirement of RSA 378:2 that schedules filed pursuant to the requirements of a duly constituted federal authority conform, as nearly as may be, with the requirements of that authority. Lastly, consistent with Staff's recommendation, to the extent IDT may have billed rates after July 3, 2012 that are higher than those in its August 30, 2012 submission, IDT shall credit its customers any difference.
