

On January 31, 2007, Verizon and FairPoint filed a pe-tition with the New Hampshire Public Utilities Commission (Commission) for approval of the transfer of Verizon's wireline local and long distance businesses

In New Hampshire to FairPoint. FairPoint is headquartered in Charlotte, North Carolina. Through certain subsidiaries, it currently pro-vides local service in East Conway and Chatham, New Hampshire, as well as in portions of Maine and Vermont.

According to the petition, the proposed transfer of assets would result in FairPoint acquiring the Verizon franchise to provide wireline telecommunication services in New Hampshire, and owning the network Verizon currently uses to provide those services.
