NOW COMES FairPoint Communications, Inc. ("FairPoint") and respectfully requests that the hearing on pending motions to compel currently scheduled for 10:00 a.m. on April 27, 2007 be continued until 1:30 p.m. on May 3, 2007. FairPoint has received the consent of all of the parties to the pending motions: the Office of Consumer Advocate; the Labor Intervenors; and Verizon. FairPoint has contacted the Hearings Examiner who has indicated that Thursday, May 3 at 1:30 p.m. is available for the continued hearing.

The parties have been working to resolve or minimize the outstanding disputes. FairPoint believes the additional time provided by this six-day continuance will contribute constructively to FairPoint's efforts concerning the disputes to which it is a party. This continuance should not adversely affect the overall procedural schedule. Responses, if any, compelled following the May 3, 2007 hearing, will be filed not later than May 10, 2007.
