PETITION TO APPROVE TRANSFER

NOW COMES Theresa Crawshaw, and, pursuant to RSA 374:30, requests the Commission to approve the transfer of all of the stock of Lakeland Management Company, Inc. to Theresa Crawshaw. In support of this petition, Petitioner states:

1. Lakeland Management Company, Inc. (the "Company") is a corporation organized and existing under the law of the State of New Hampshire. The Company is a public utility, owning and operating a public water supply system and sewer system in the Town of Belmont, New Hampshire. The Company's address is PO Box 7394, Gilford, NH 03247.

2. Petitioner is an individual with an address of P.O. Box 7394, Gilford, NH 03247. Petitioner is part owner of C&C Water Services, Inc. ("C&C"), with the remaining shares of C&C being owned by her son, Alex L. Crawshaw, an engineer. Petitioner is also the sole shareholder of White Rock Water Company, Inc., a public utility in the Town of Bow, New Hampshire. Since 2008, Petitioner has served as the non-technical services manager of the Company. For approximately 8 years Petitioner has also served as the non-technical services business of C&C and White Rock Water Company, Inc.

3. Petitioner is the widow of Wade R. Crawshaw, the former owner of the stock of the Company from 2008 to just before his death in November 2011. Wade Crawshaw transferred his stock in the Company to Petitioner shortly before his untimely death in November 2011.

4. The capital stock of the Company consists of 100 shares of common stock with no par value.

5. C&C is in the business of operating water systems. C&C is the current operator of the Company's water and sewer systems in the Town of Belmont, New Hampshire, and has been for several years.

6. The transfer is in the public good.

7. This petition is submitted without prejudice to Petitioner's claim that the transfer of the stock of the Company does not require Commission approval.




