On July 12, 2012, Northland Telephone of Maine, Inc. d/b/a FairPoint Communications-Northland Telephone of New Hampshire, Inc. filed a request seeking approval of an agreement with Time Warner Cable Information Services (New Hampshire), LLC to adopt the terms of an Interconnection Agreement between Northland and CRC Communications of Maine, pursuant to 47 U.S.C. §252(i).

The Commission elects to take no action on this petition. Accordingly, pursuant to 47 U.S.C. §252(e)(4), the adoption of the Interconnection Agreement will take effect by operation of law 90 days after its filing, on or about October 10, 2011. Notwithstanding the foregoing, any clause in the Agreement found to be in violation of any Commission order is null and void.

The Commission has updated its records to include the adoption of this Agreement. Docket No. DT 12-209 has been assigned for future reference.
