On July 25, 2012, KEI (Maine) Power Management (II) LLC (KEI) submitted an application requesting certification for its Pumpkin Hill (Lowell Tannery) Hydroelectric Project (Pumpkin Hill Hydro) located on the Passadumkeag River in Lowell, Maine. On August 01, 2012, KEI sent, as a supplement to the request for certification as a Class IV renewable energy source, a copy of its Power Purchase Agreement with Bangor Hydro-Electric Company.

Pursuant to Puc 2504.01 (2), New Hampshire Class IV REC eligibility is contingent on documentation that the source was settled in the ISO-New England wholesale market system. Staff has brought to your attention that the Asset Identification Number (Asset ID #) submitted for this hydro facility is not valid. In response, KEI informed the Commission that Pumpkin Hill has no Asset ID # at this time since it is treated in a pool of resources by Bangor Hydro Electric Company (Bangor Hydro).

Without an asset identification number or a GIS facility code, the Commission has no way of delineating the RECs generated from Pumpkin Hill Hydro from the general Bangor Hydro system. Accordingly, the Commission has denied, without prejudice, your request that the Pumpkin Hill Hydro facility be certified as a Class IV renewable energy source eligible to acquire Class IV RECs.
