AFFIDAVIT OF HARRY N. MALONE


The undersigned, Harry N. Malone, being first duly sworn, deposes and says as follows:

1. 2. The attached confirmation of certified mailings from the United States Postal Service shows that copies of Order No. 25,424 were signed for and received according the provisions of the Order.


