Dear Ms. Howland:

Per its letter dated October 7, 2013, filed with the New Hampshire Public Utilities Commission (the "Commission") on October 9, 2013, Contoocook Hydro, LLC ("Contoocook" or the "Applicant") submitted Monthly Electric Generation Records (1986-2013) pertaining to its Application for Class I certification for a portion of the generation from its Hopkinton Hydro Project (the "Project" or the "Facility"). The Applicant requested that this information be afforded confidential treatment by the Commission.

Commission Staff has objected to the Applicant's request that this information be given confidential treatment. The Applicant has revised its submittal, producing a public version of the historical annual generation production records of the Project for the period 1986 through 2012, at Staff's suggestion. Accordingly, enclosed please find Contoocook's submission of a summary table of Annual Generation for Hopkinton Hydro (MWh) (1986-2012), which the Applicant does not consider to contain any confidential, material non-public information.

Contoocook wishes to inform the Commission that it believes that the Commission is still in possession of confidential, material non-public information and/or information in excess of the information on its Project requested by Staff, specifically the monthly generation records of the Project from 1995 through 2013. The Applicant request that all such information submitted with its October 9, 2013 filing be returned to the Applicant or, in the alternative, be destroyed.
