# THE STATE OF NEW HAMPSHIRE PUBLIC UTILITIES COMMISSION DRM 12-298 RULEMAKING N. H. Code Admin. Rules PART Puc 1400, Rules for Pipeline Utilities

# ORDER OF NOTICE

On December 19, 2012, the Commission voted pursuant to RSA 541-A to initiate a rulemaking for N. H. Code Admin. Rules PART Puc 1400, Rules for Pipeline Utilities. The Commission's Initial Proposal represents a readoption of the existing Puc 1400 rules with amendments. The proposed revisions to Puc 1400 are intended to clarify existing requirements regarding the circumstances when test results and summaries of records shall be provided to the Commission. Upon approval, the proposed amended rule will replace the current version of Puc 1400.

A rulemaking notice form (Notice), as required by RSA 541-A:6, was filed with the Office of Legislative Services on December 20, 2012, and published on December 27, 2012. The Notice sets forth a date for a public hearing to be held at the Commission on January 22, 2013, at 10:00 a.m. and a deadline for submission of written comments of January 29, 2013. That notice is appended hereto.

A copy of the Rulemaking Notice will be sent to all regulated gas utilities and interstate gas pipeline operators, and to those parties previously requesting notice of rulemakings pertaining generally to utility service and customer relations. Pursuant to RSA 541-A:6, III, notice will also be provided by public notice advertisement in a publication of daily statewide circulation.

The readoption with amendment Initial Proposal may be viewed on the Commission website, <u>http://www.puc.nh.gov/Regulatory/Docketbk/2012/12-298.html</u>, or copies may be obtained from the Commission as set forth in the Notice.

### Based upon the foregoing, it is hereby

**ORDERED**, that a Public Hearing, pursuant to 541-A:11, be held before the Commission located at 21 South Fruit Street, Suite 10, Concord, New Hampshire on January 22, 2013, at 10:00 a.m., and that the deadline for submission of materials in writing or via e-mail shall be January 29, 2013, as set forth in the Notice; and it is

**FURTHER ORDERED**, that pursuant to RSA 541-A:6, III, the Commission shall undertake a public notice advertisement by publishing a copy of this Order together with the Notice no later than January 11, 2013, in a newspaper with a daily statewide circulation, publication to be documented by affidavit filed with the Commission on or before January 22, 2013.

The Puc 1400 rules generally apply to any public utility that owns or operates any gas pipeline, including pumping stations, storage depots and other facilities, for the transportation, distribution or sale of gas, crude petroleum, refined petroleum products, or combinations of petroleum products.
