In support thereof the Town of North Hampton states the following:

1. Aquarion Water Company of New Hampshire, Inc. provides water service to the Town of North Hampton.

2. Thus, the rights, duties, privileges, immunities and substantial interests of its citizenry will be affected by this proceeding.

3. Moreover, water costs and Aquarion's building construction costs at their facility directly affect land values and economic development within the municipality.

4. The interests of justice would be served and the orderly and prompt conduct of the proceedings would not be impaired by allowing the intervention.


