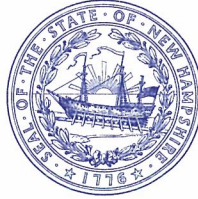

Newly Identified Possible Collocators Made Necessary Parties

To the Parties:

On June 28, 2013, Staff advised the Commission that two additional possible collocators at certain of FairPoint's wire centers were identified during the technical session held in this docket on June 5, 2013, and Staff recommended that these two possible collocators be added as necessary parties in the docket. The newly identified carriers are Teljet Longhaul, LLC and New Hampshire Optical Systems, Inc., each of which is currently registered with the Commission as a competitive local exchange carrier.

The Commission has determined that, in order to conduct discovery with respect to these newly identified possible collocators, they should be made necessary parties in this docket in accordance with Order No. 25,456 and Order No. 25,514. Accordingly, Teljet Longhaul, LLC and New Hampshire Optical Systems, Inc. are made necessary parties in this docket.
