Northern New England Telephone Operations LLC d/b/a FairPoint Communications – NNE (“FairPoint”) is filing for effect October 7, 2013 tariff changes consisting of:

On November 16, 2012, FairPoint filed a revision to its NH PUC Tariff No. 2 to implement certain provisions of the *Order on Remand* issued by the Federal Communications Commission on February 4, 2005, in WC Docket No. 04-313 and CC Docket No. 01-338 (the “*Triennial Review Remand Order*”) by designating certain wire centers as unimpaired for DS1 and DS3 Interoffice Transport. On January 17, 2013, the New Hampshire Public Utilities Commission (“Commission”) issued Order No. 25,456, rejecting the proposed tariff revisions without prejudice and opening an investigation into the level of competition in the reclassified wire centers.

On October 7, 2013 and at the conclusion of this Docket, the Commission issued Order 25,580 and pursuant to that Order, FairPoint is filing the above noted changes to its NHPUC No. 2. FairPoint hereby removes Durham from the list of exempt wire centers and extends the transition period for dark fiber interoffice transport UNEs under NHPUC Tariff No. 2 for the wire centers located in Dover, Hanover, Keene, Nashua, Portsmouth and Salem for a period of six months, terminating on August 15, 2014.
