To the Parties:

On February 12, 2013, a duly noticed prehearing conference was held in the above referenced proceeding. On February 25, 2013, Alexander Speidel, Esq. acting as hearings examiner pursuant to RSA 363:17, submitted his report and recommendations. Appearances at the prehearing conference were entered by representatives of Bedford Waste Services Corporation, Bedford Three Corner Owners Association, Inc., and Commission Staff. The Office of the Consumer Advocate has a statutory right to participate in the proceeding but chose not to at this time. The intervention of Bedford Three Corner Owners Association, Inc. was granted.

Following the prehearing conference, the parties and Staff met in a technical session and agreed upon the following schedule which was submitted to the Commission by letter from Staff dated February 14, 2013:
