On February 27, 2013, you submitted an application on behalf of New Hampshire resident John David Carmody (Carmody) requesting that the Commission grant approval of the photovoltaic facility located at his residence to produce Class II. Renewable Energy Certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the Carmody application and has recommended approval of his photovoltaic array as eligible for Class II RECs effective February 27, 2013.

Since this facility is a customer-sited source, the output is not recorded in the New England Power Pool Market Settlement System and, as a result the output must be monitored and verified by an independent monitor. Your application states that NHEC will monitor the facility's output pursuant to N.H. Code of Administrative Rules Puc 2505.09. This facility's total output will also be included in the NHEC Class II Aggregation's total output reported to the NEPOOL Generation Information System as approved by the Commission on April 9, 2010.
