11	A.	I am employed by Liberty Energy Utilities (New Hampshire) Corp. ("Liberty Energy		
12		NH") as its Director and Head of Regulatory, Government and Community Affairs.		
13		Liberty Energy NH provides services to Granite State Electric Company. My		
4		management responsibilities are primarily in the areas of compliance, financial and		
5		regulatory services.

19 20	A.	I received a Bachelor of Science degree in Mathematics Education from the University of		
21		New Hampshire in 1977 and a Master's in Business Administration from the University		
22		of New Hampshire in 1979.

28	A.	From June 1979 to August 2013, I was employed by Public Service Company of New		
29		Hampshire ("PSNH"), most recently as the Manager of Revenue Requirements. In this		
30		capacity, I was responsible for a wide range of rate and regulatory matters for PSNH,		

1		including distribution rate cases, energy service rates, stranded cost recovery, and
2		transmission cost recovery. I was also responsible for regulatory relations for PSNH, and
3		had supervisory responsibility for revenue requirements. I also previously had
4		responsibility for pricing, rate design and tariff administration.
