Dear Corey Rose Akios:

On May 1, 2013, the Commission received BidURenergy's notice of intent to renew its registration to provide electric aggregation services pursuant to Puc 2003.05. BidURenergy filed its initial notice of intent in 2010, which the Commission approved by letter dated May 11, 2010 (effective April 19, 2010), and which approval was valid for two years. *See* Docket No. DM 10-110. On March 22, 2012, BidURenergy filed a renewal notice which the Commission approved effective April 19, 2012. *See* Docket No. DM 12-073.

Pursuant to Puc 2003.05 (a), the 2012 renewal is effective for five years or until the close of business April 18, 2017. Since BidURenergy's registration is valid until 2017, the 2013 application is premature and Docket No. 13-118 is hereby dismissed. I apologize if you filed at the suggestion of this office. Enclosed is a check for \$250 to refund your filing fee.

Please be advised that you must file the next renewal application at least 60 days before the April 19, 2017 expiration date, on or before February 18, 2017, if you continue to provide aggregation services in New Hampshire.
