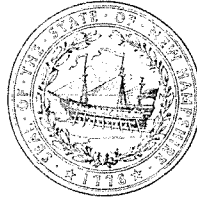

Dear Mr. Schiff:

On May 3, 2013, Ultimate Energy Advisors filed an application with the Commission for registration as a natural gas aggregator together with the initial application fee of \$250.00. On May 20, 2013, Ultimate Energy Advisors filed revisions to its application.

Following its review of the filing, as revised, Commission Staff has determined that the application for registration as a natural gas aggregator meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.05. The Commission, therefore, approves Ultimate Energy Advisors' application as an aggregator in the State of New Hampshire, with the registration to become effective May 30, 2013. This registration will expire at the end of business on May 29, 2015.


Please be aware that, pursuant to N.H. Code Admin. Rules Puc 3003.02(a), each aggregator shall re-register with the Commission by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of Ultimate Energy Advisors, on or before March 31, 2018. Please file a timely renewal application.

All registered natural gas aggregators in the State of New Hampshire are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules can be found on our website at:
