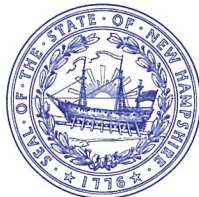

Dear Ms. Howland:

Staff and the parties to the above dockets have conducted discovery and have come to agreement on most of the issues. As such, we do not believe additional discovery is necessary to fully develop the issues and record. We consider the issues to be largely undisputed.

In light of that, Staff and the parties have discussed revising the procedural schedules and propose that the schedules be modified to reflect: testimony from Staff, Office of the Consumer Advocate (OCA), Intervenors due April 14, 2014, and hearings on the merits on May 20, 2014 with PEU scheduled for 9 AM, PAC scheduled for 1 PM, and PWW scheduled for 3 PM. At this time, Staff does not expect to file testimony.

Staff and the parties envision filing settlement agreements in these dockets and will do so pursuant to Puc 203.20 which requires agreements to be filed at least five days prior to the hearing. Thank you in advance for your consideration of the proposed revisions to the procedural schedule.
