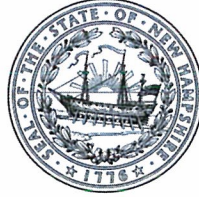

To the Parties:

On October 30, 2014, counsel for Pennichuck East Utility, Inc. (Pennichuck) filed a request for an extension of time to file the reconciliation calculations in the above-referenced proceeding. In the request, it was noted that Pennichuck is experiencing personnel issues affecting the time and labor needed to determine customer-specific surcharges. It was further noted that the Staff, the Office of Consumer Advocate, and the Town of Litchfield do not oppose the request.

The Commission has determined that granting the request will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, Pennichuck's reconciliation calculations are due November 14, 2014.
