TOWN OF LITCHFIELD'S PETITION TO INTERVENE

NOW COMES the Town of Litchfield, by and through its attorneys, Mitchell Municipal Group, P.A., and in petitioning the Commission to allow it to intervene in the above captioned matter states as follows:

1. On May 31, 2013 Pittsfield East Utility, Inc. ("PEU") filed a petition for temporary rates and for an increase in permanent rates.
2. Pursuant to RSA 541-A:32 and PUS 203.17, the Town of Litchfield petitions the Commission to permit it to intervene in this matter.
3. PEU supplies many of the homes in the town with water. In addition, the town is one of PEU's customers.
4. Given the proposed rate increase, the rights, duties, privileges, immunities and other substantial interests of the town and its residents may be affected by the present proceeding.
5. The interests of justice and the orderly and prompt conduct of the proceedings would not be impaired by allowing the intervention.

WHEREFORE, the Town of Litchfield respectfully requests that this Commission:

- A. Allow it to intervene in the above captioned matter; and
- B. Grant such other and further relief as the court deems just and necessary.




