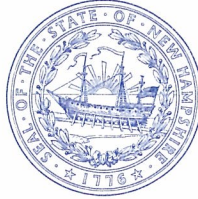

Rescheduling of Hearings

To the Parties:

On October 3, 2013, counsel for Pennichuck Water Works, Inc. filed a motion to reschedule hearing in the above-referenced proceeding. The motion proposed that the hearing scheduled for October 10, 2013 be rescheduled to October 22, 2013, the same day as the Pittsfield Aqueduct Company, Inc.'s hearing on temporary rates. The motion also states that Commission Staff and the Office of Consumer Advocate concur with the request.

The Commission has determined that rescheduling the hearings will promote the orderly and efficient conduct of the proceeding. Accordingly, the temporary rate hearing in DW 13-130, Pennichuck Water Works, Inc. is rescheduled to October 22, 2013 at 10:30 a.m., and the temporary rate hearing in DW 13-128, Pittsfield Aqueduct Company, Inc. will commence at 9:00 a.m. on the same day.
